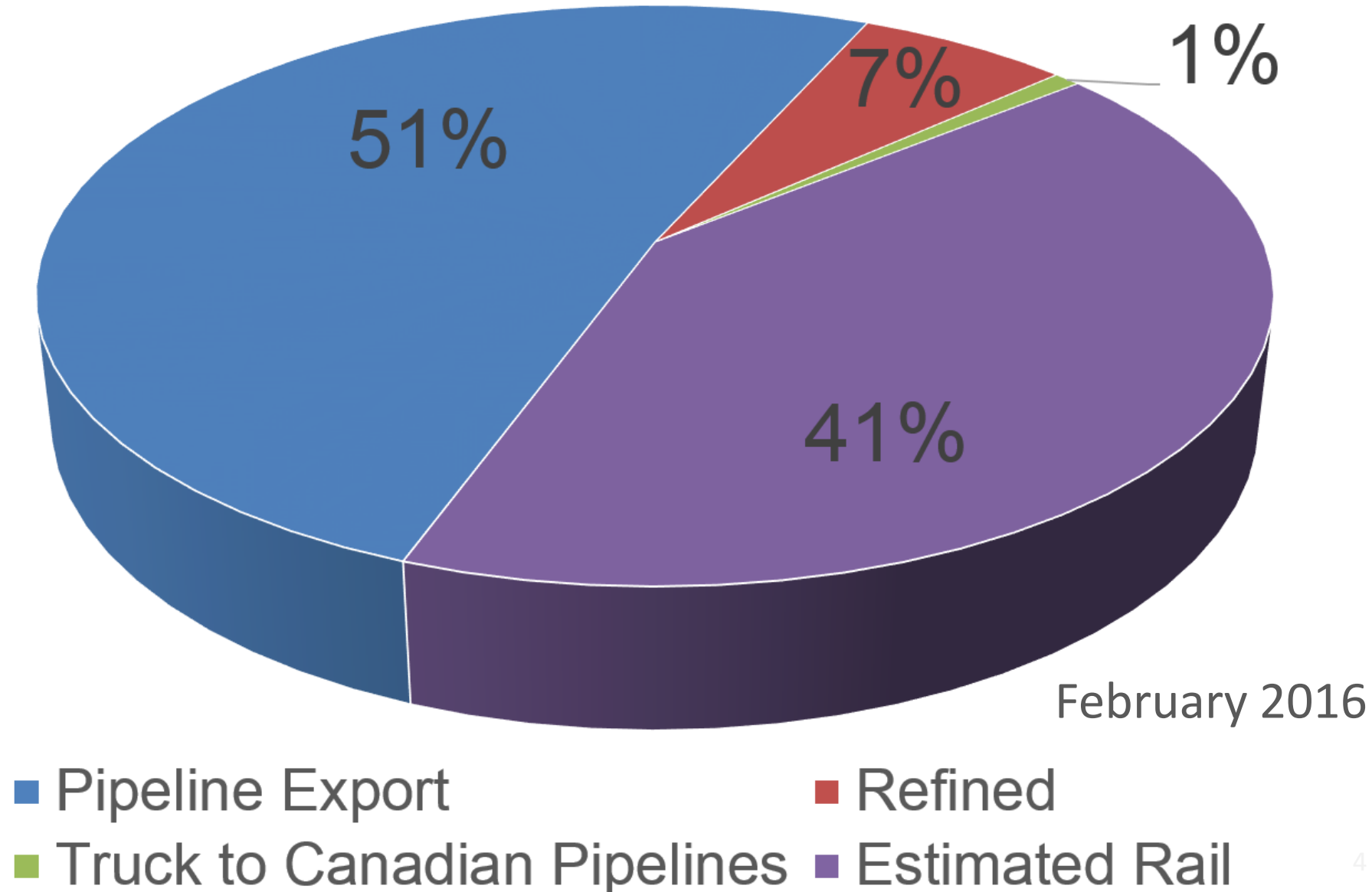

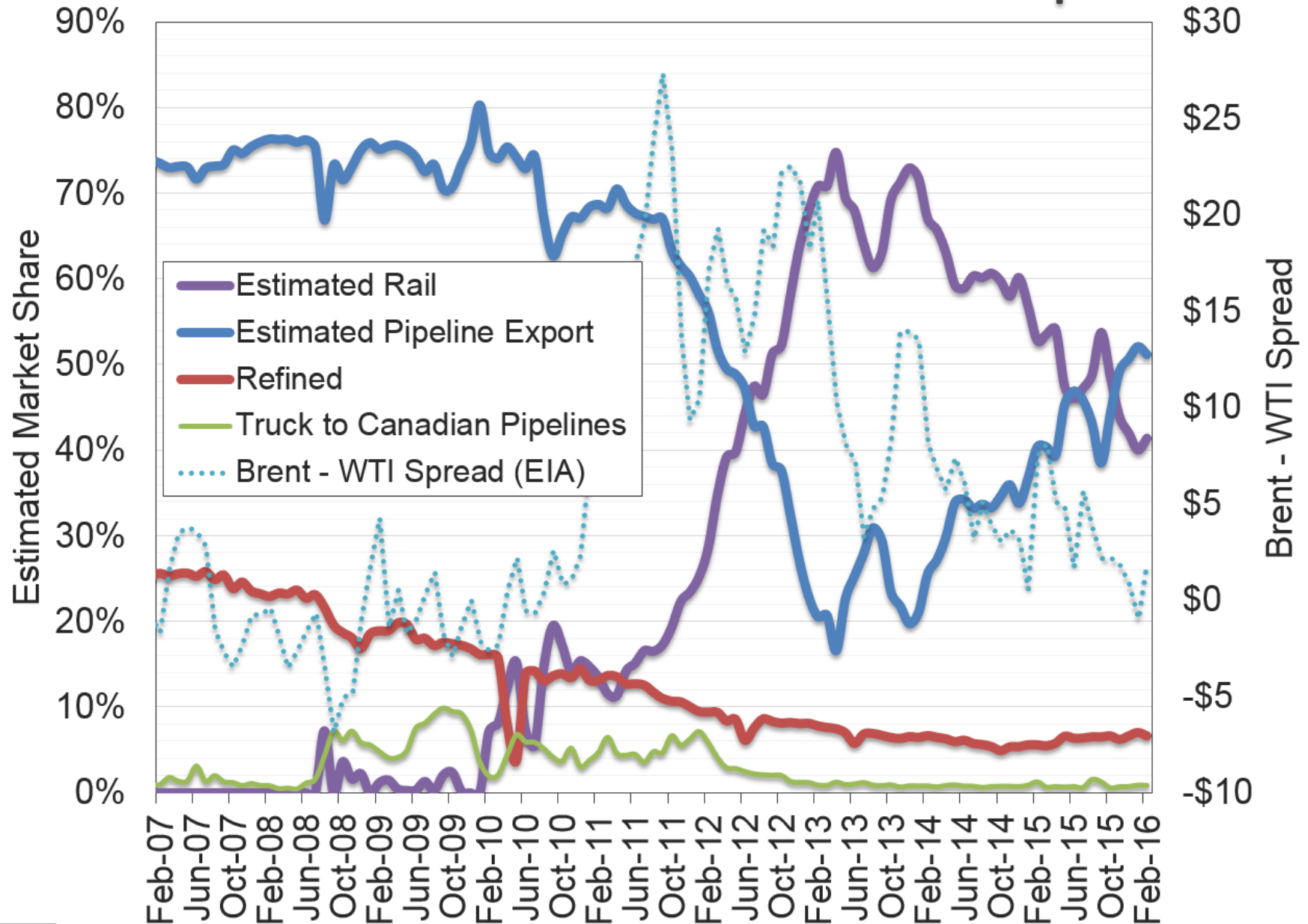

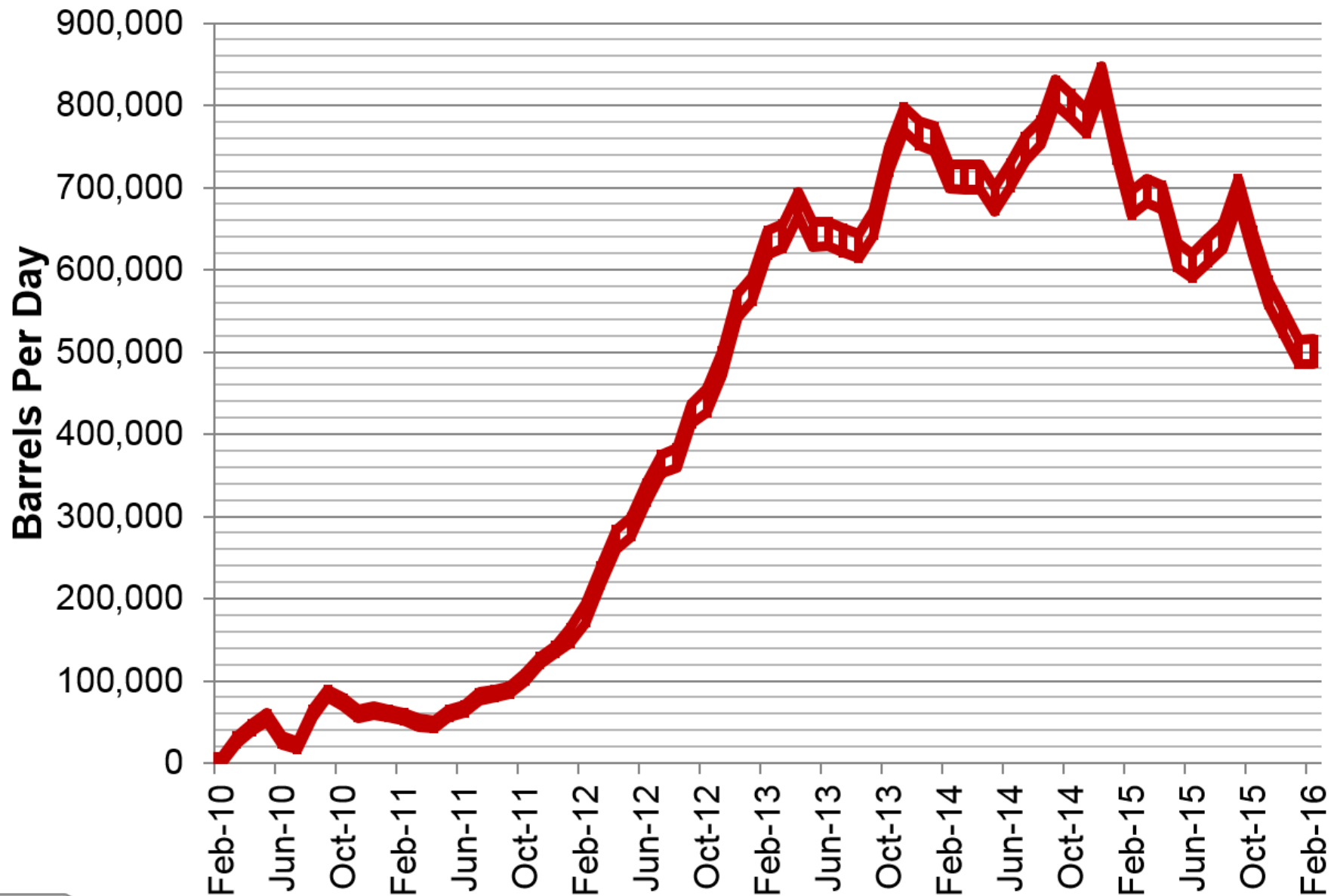
# Estimated Williston Basin Oil Transportation



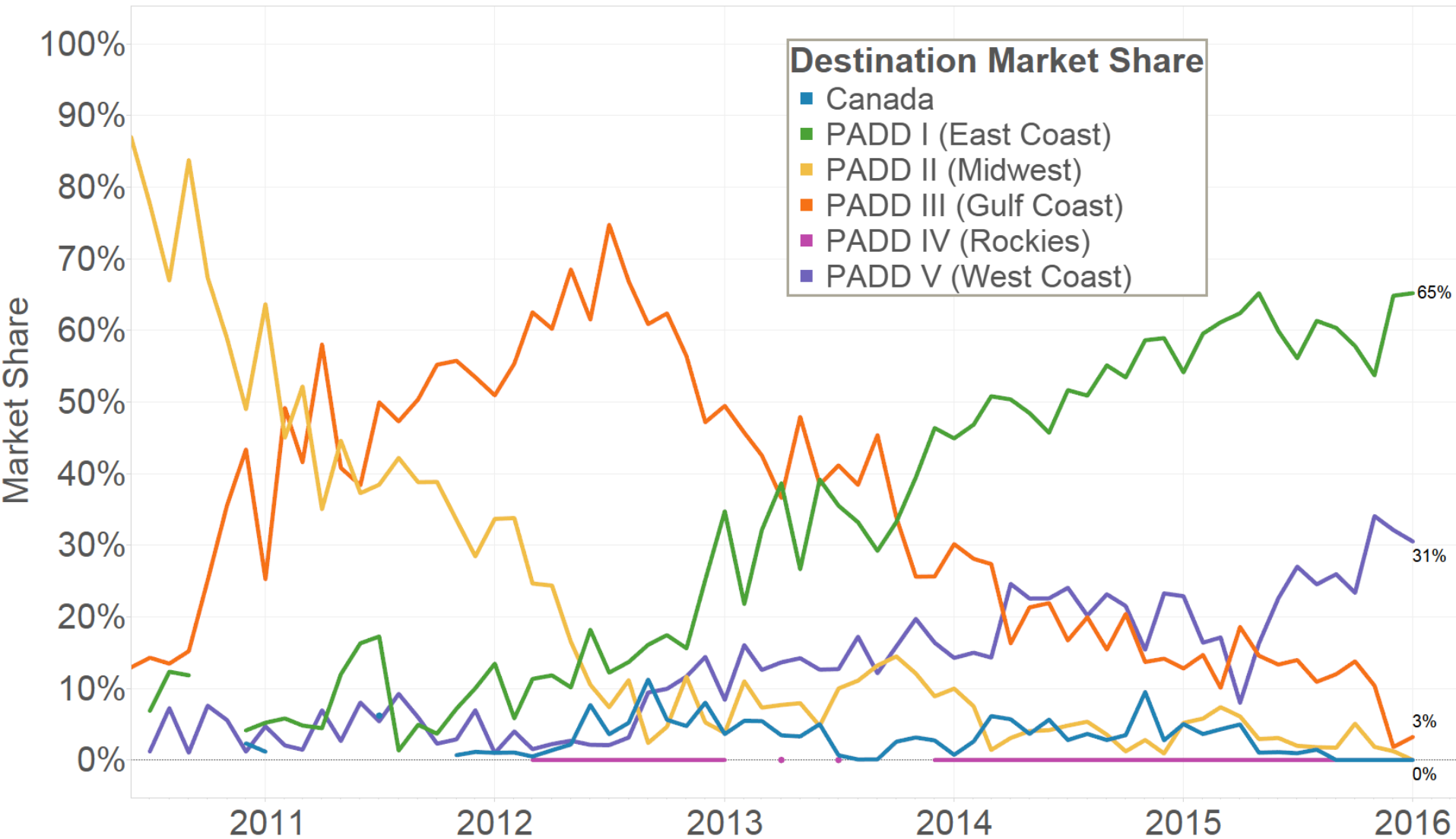

# Rail Destinations Market Share (Jan 2016)

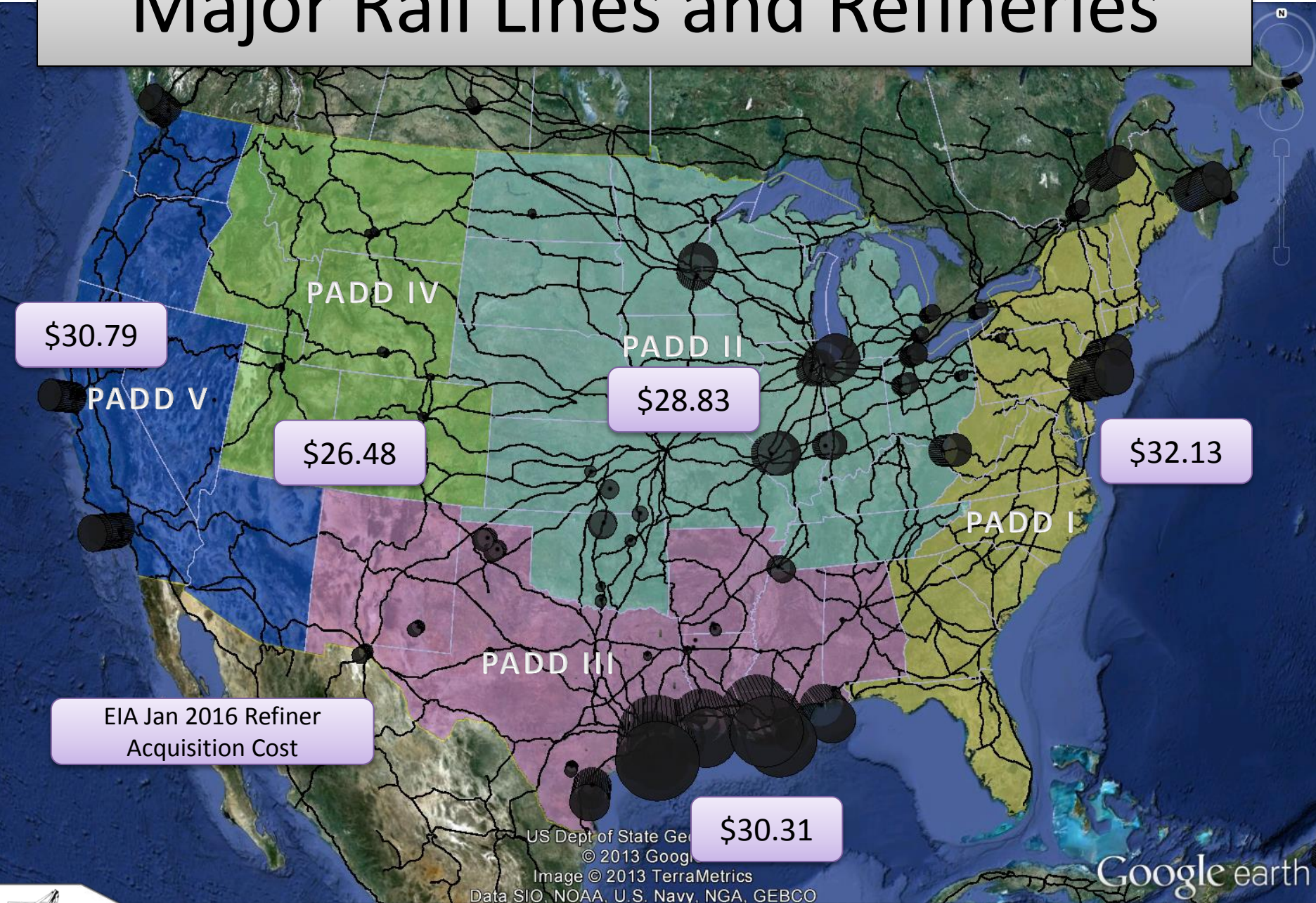

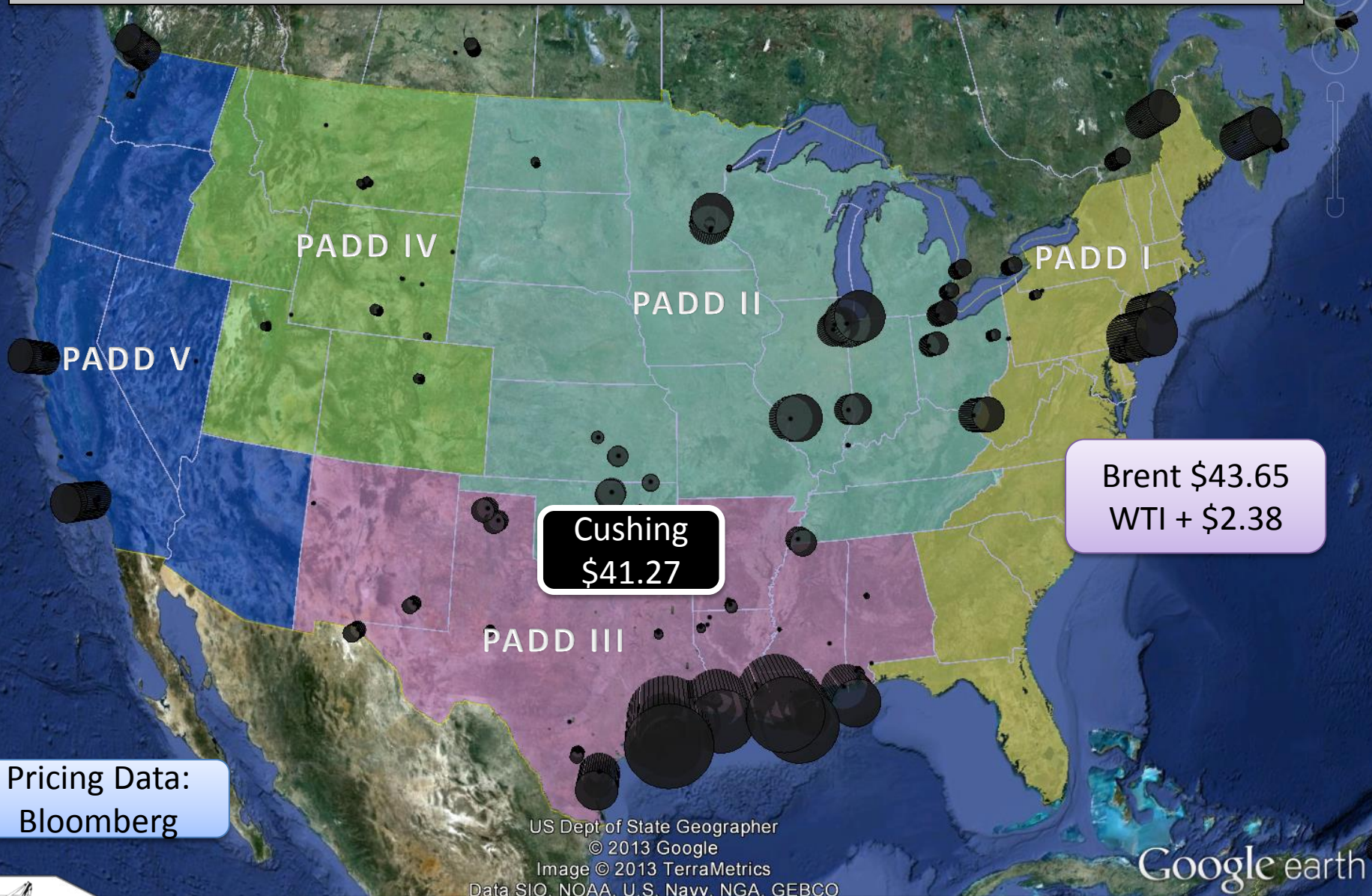

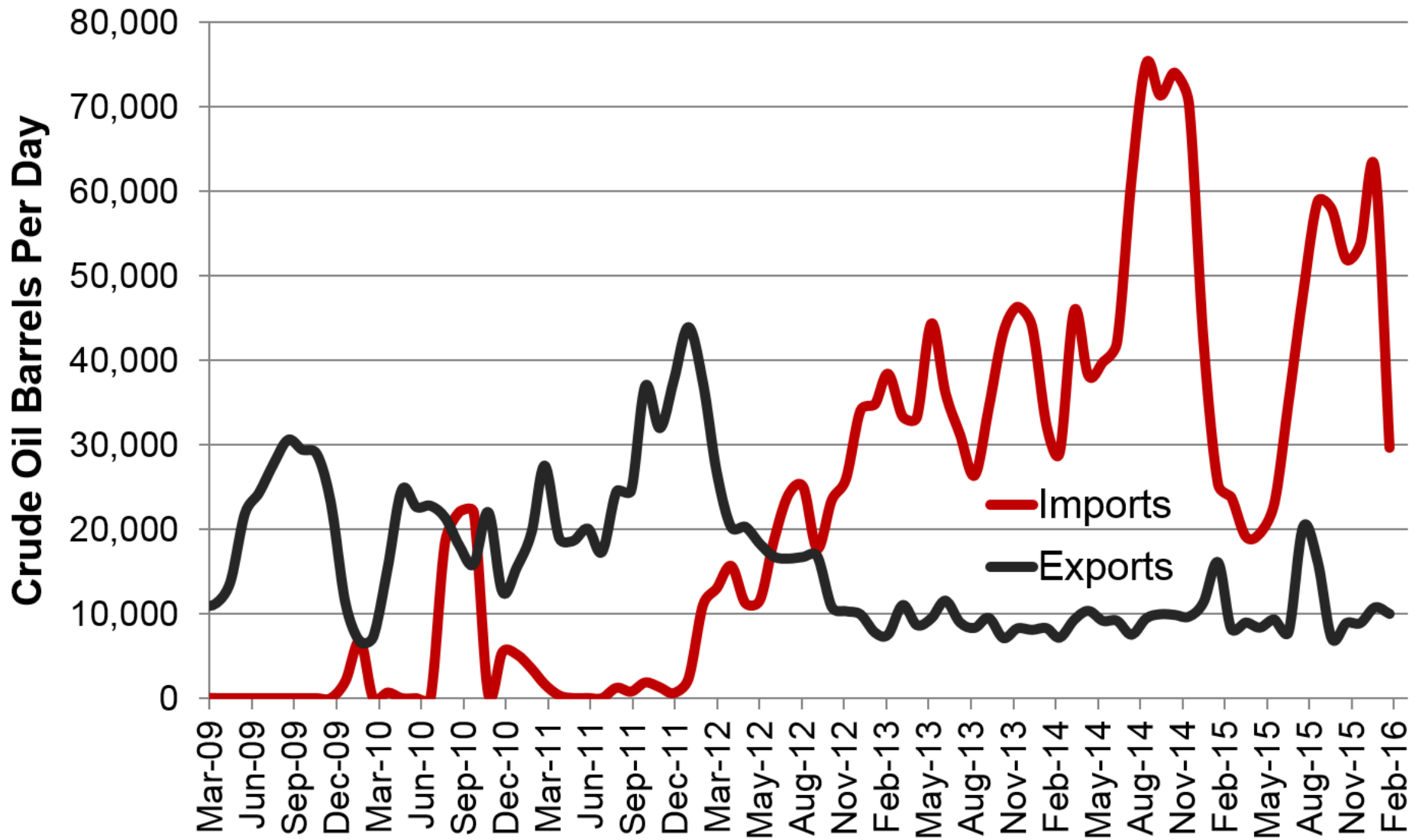




# Crude Oil Prices – Apr. 14, 2016



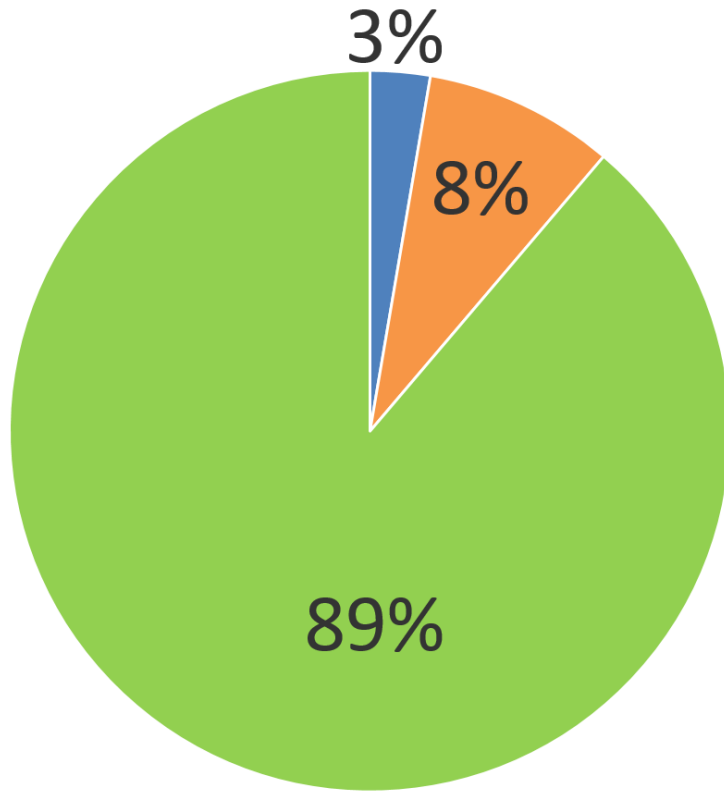
# ***Williston Basin Truck Imports and Exports with Canada***

**Orange** – % flared from wells with at least one mcf sold.

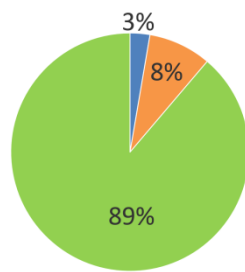
## Simple Terms

**Orange** – Challenges on existing infrastructure

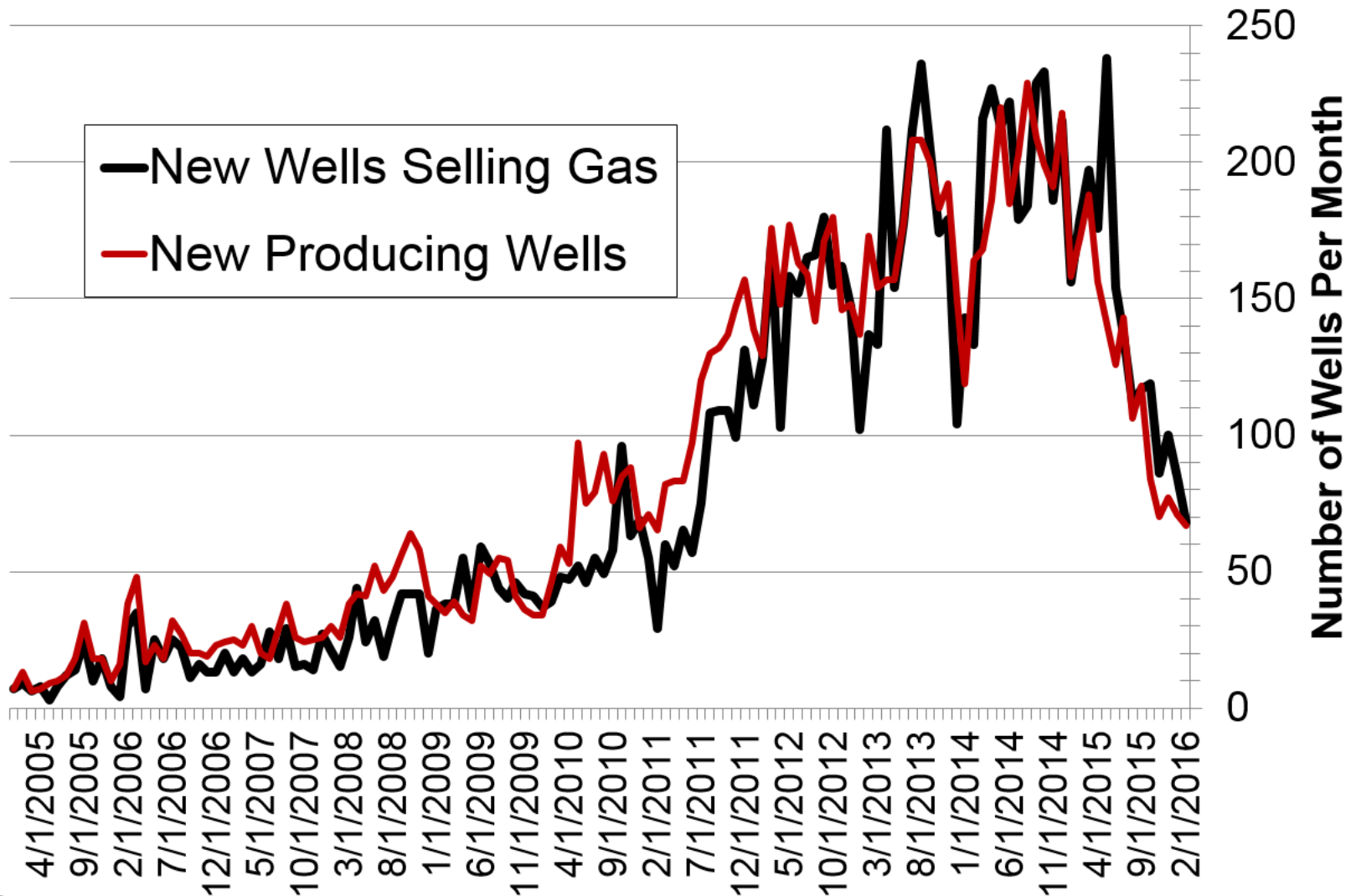
