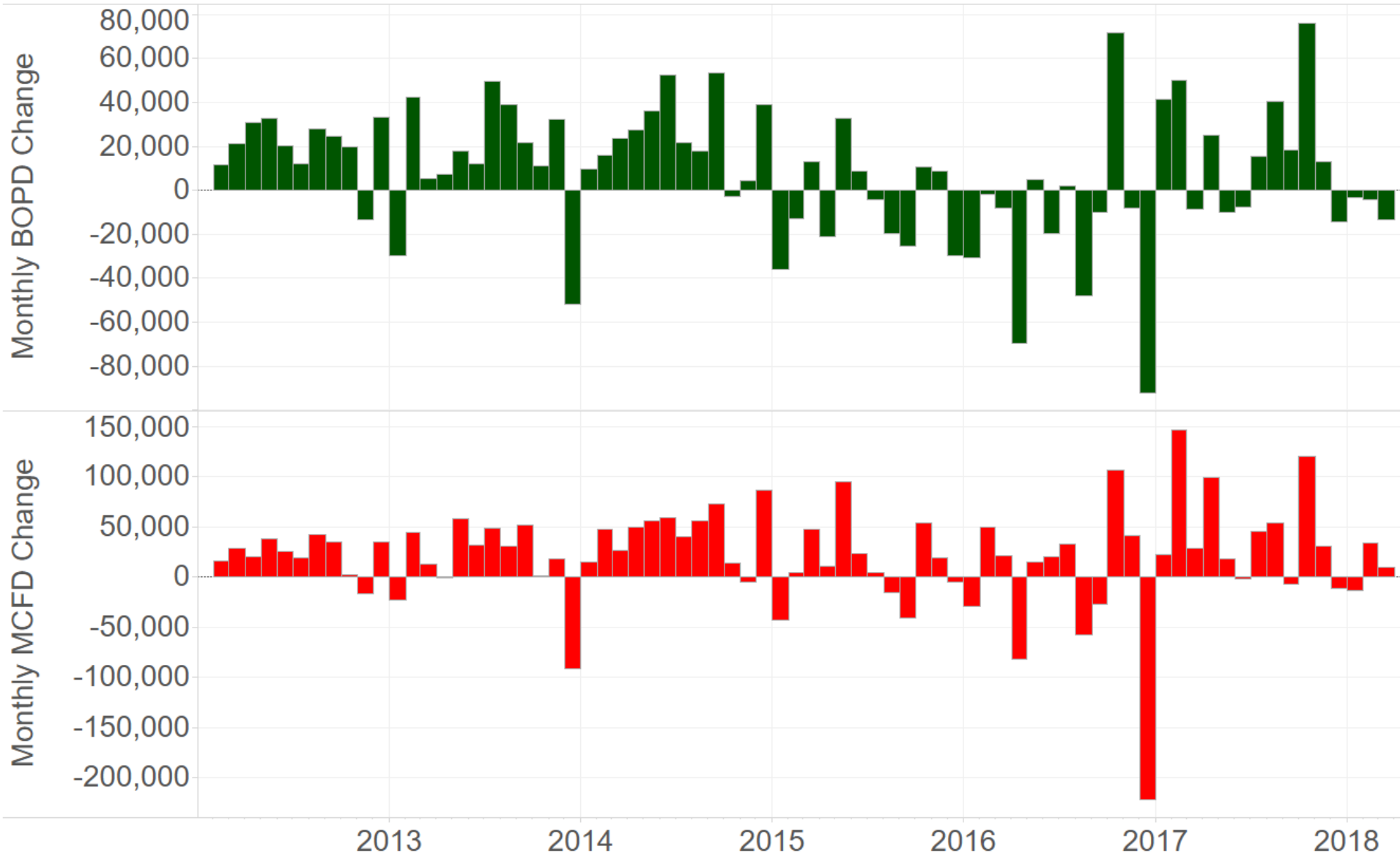

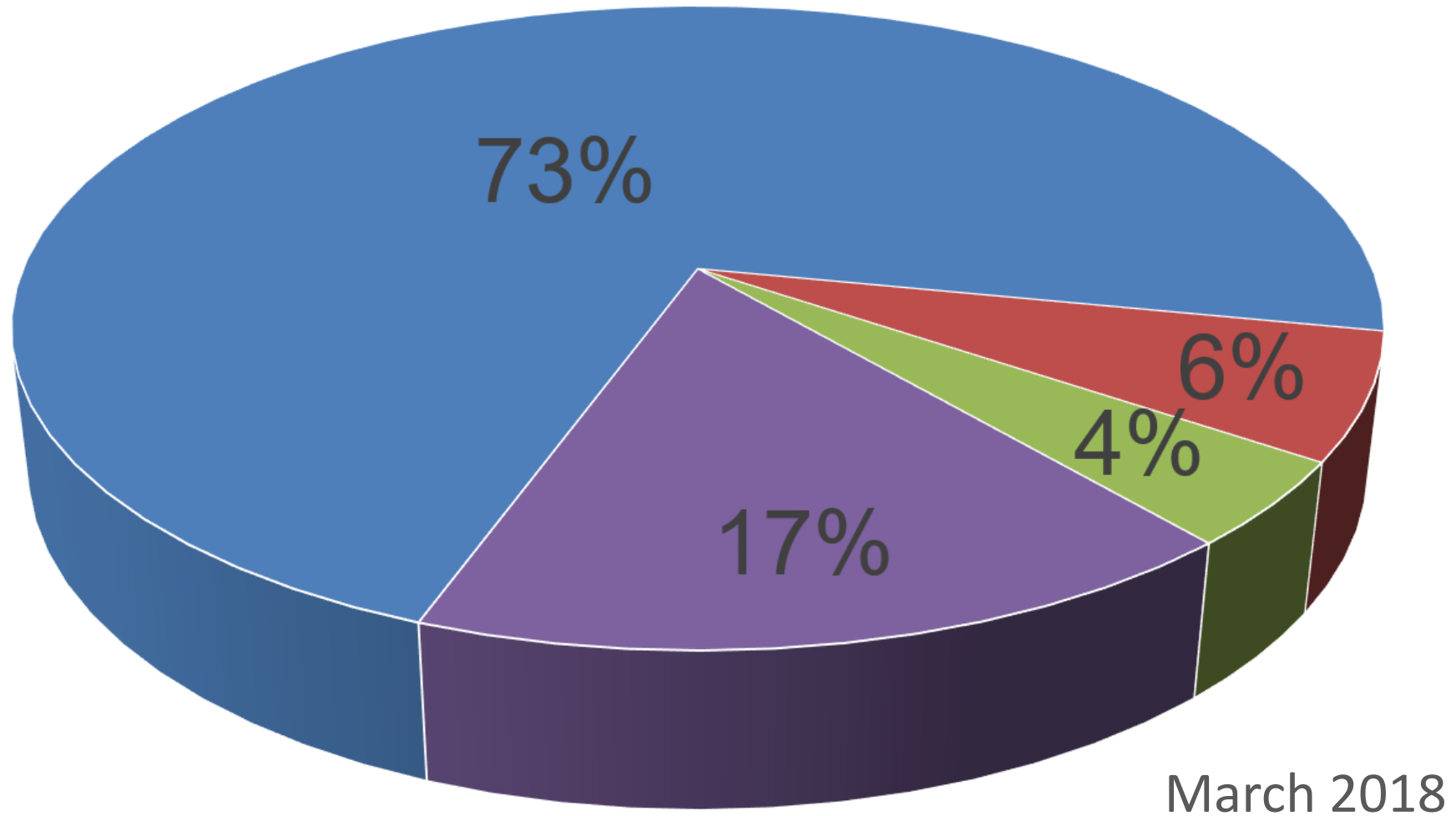

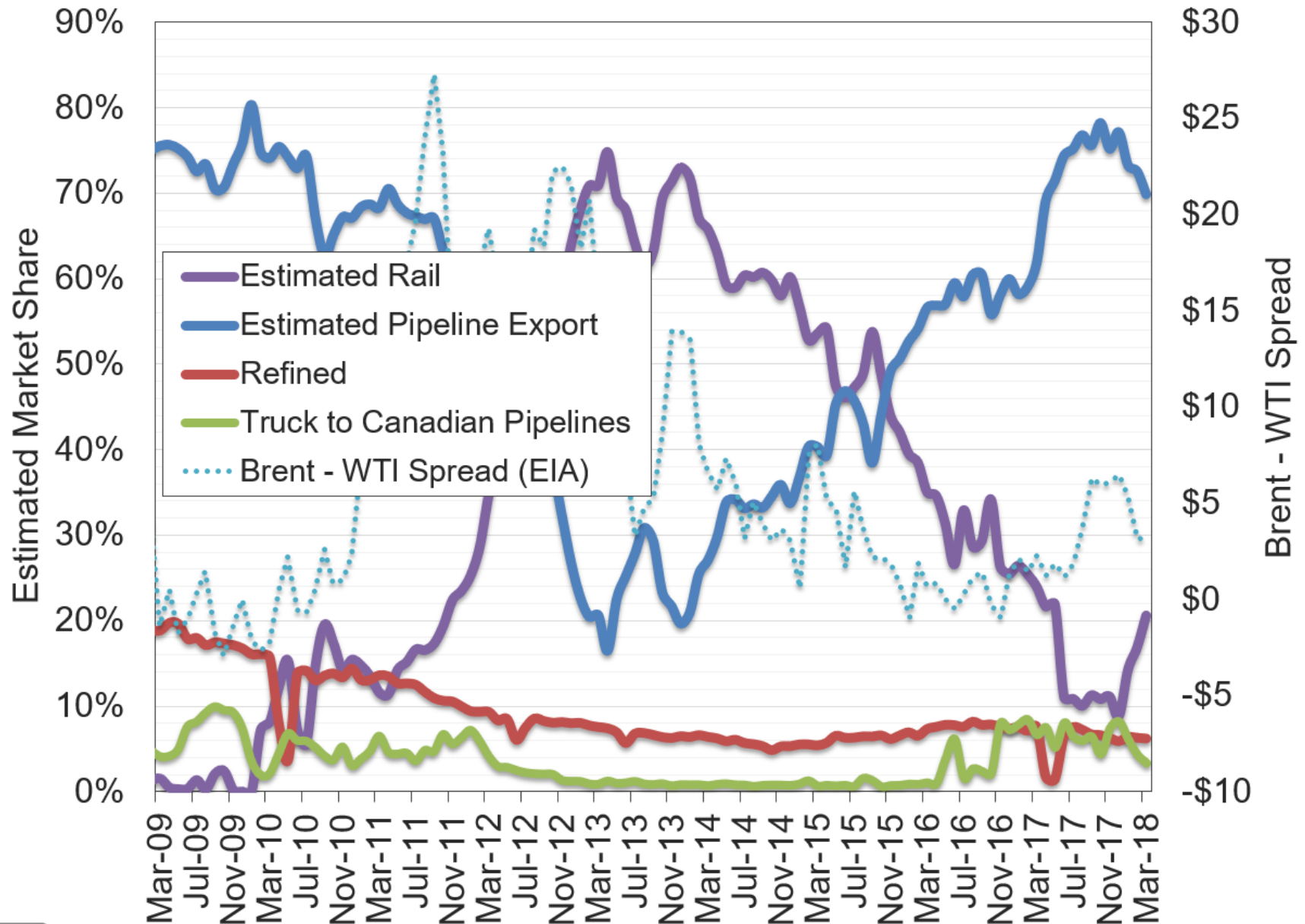

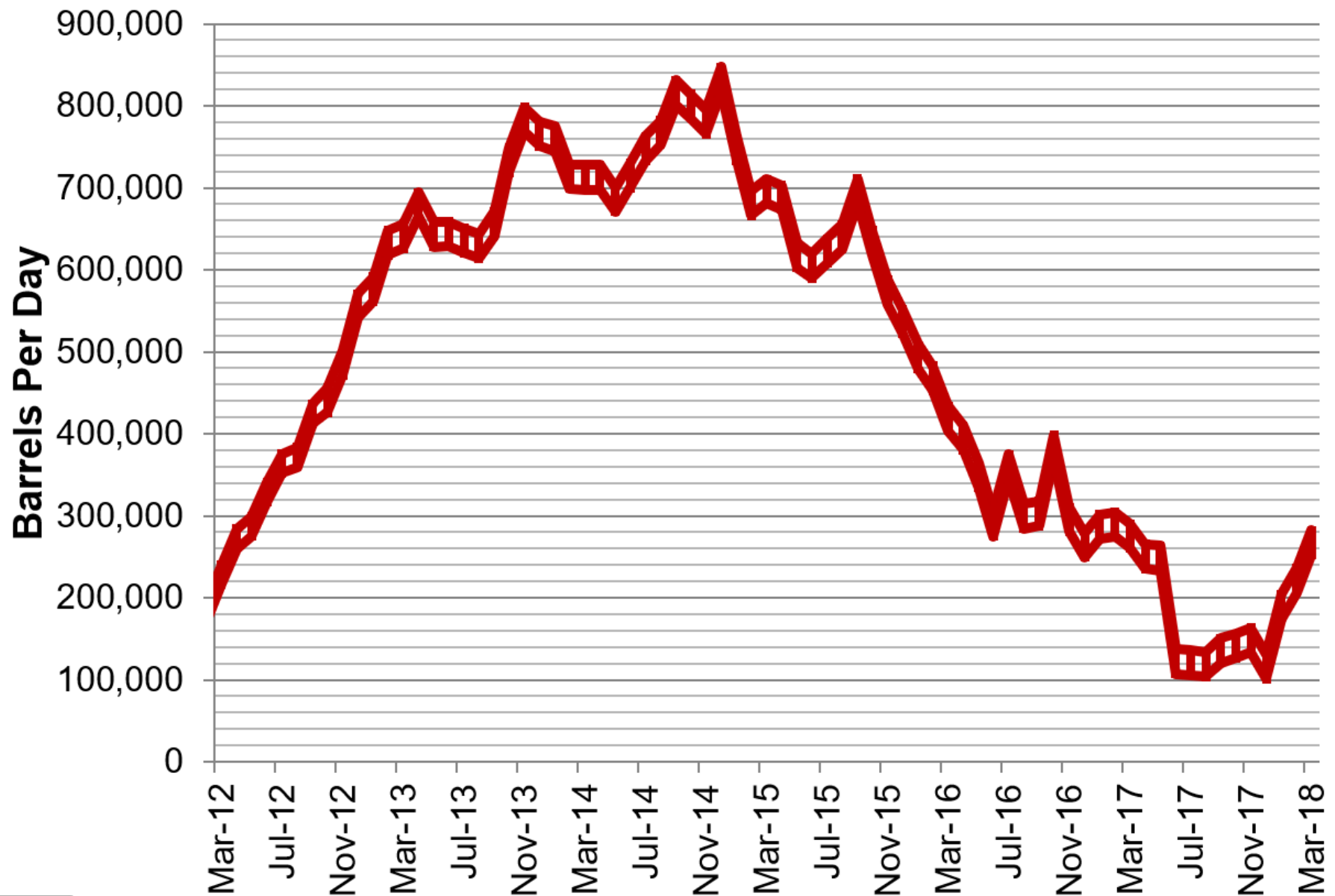

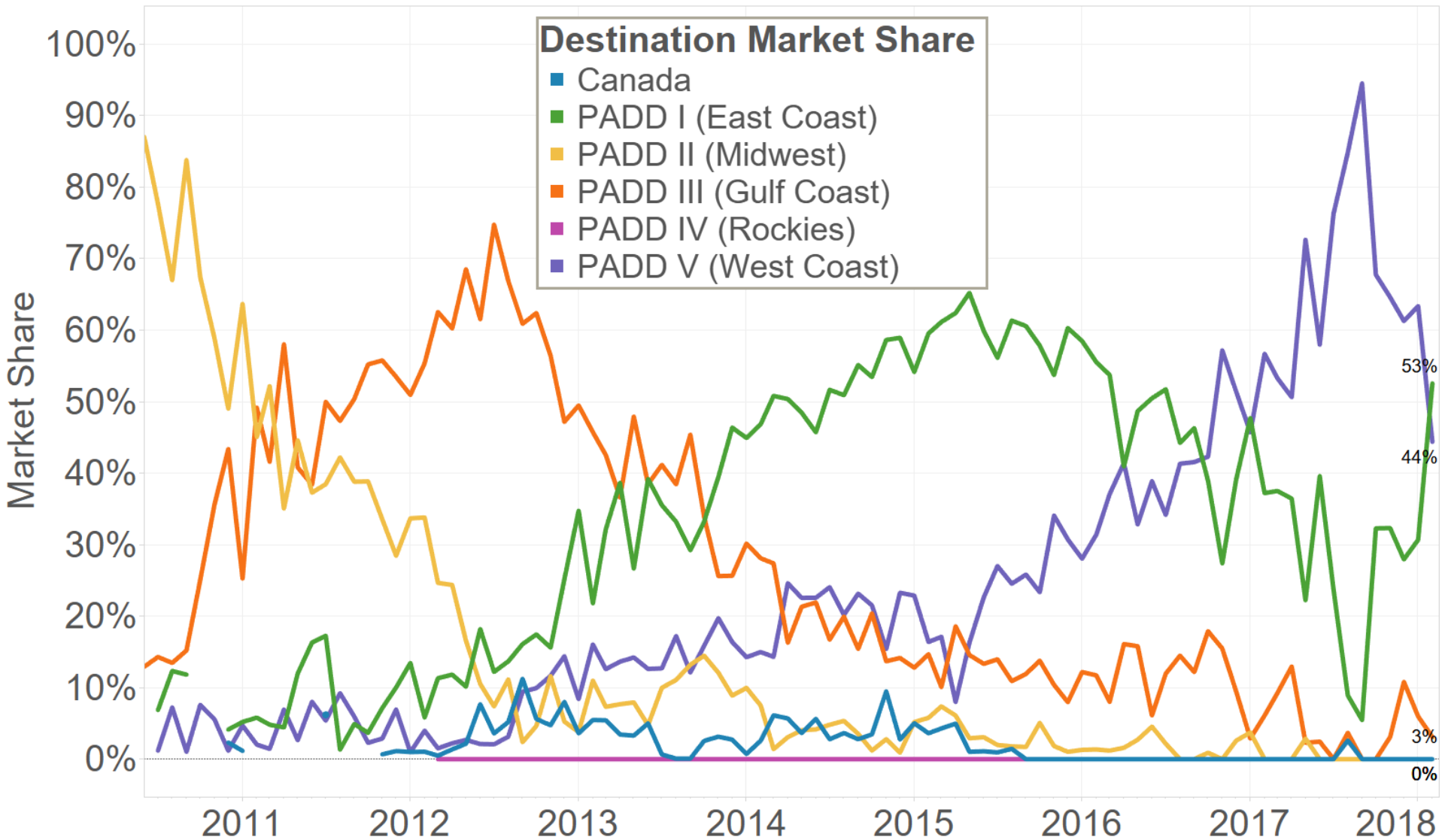

Estimated ND Rail Export Volumes



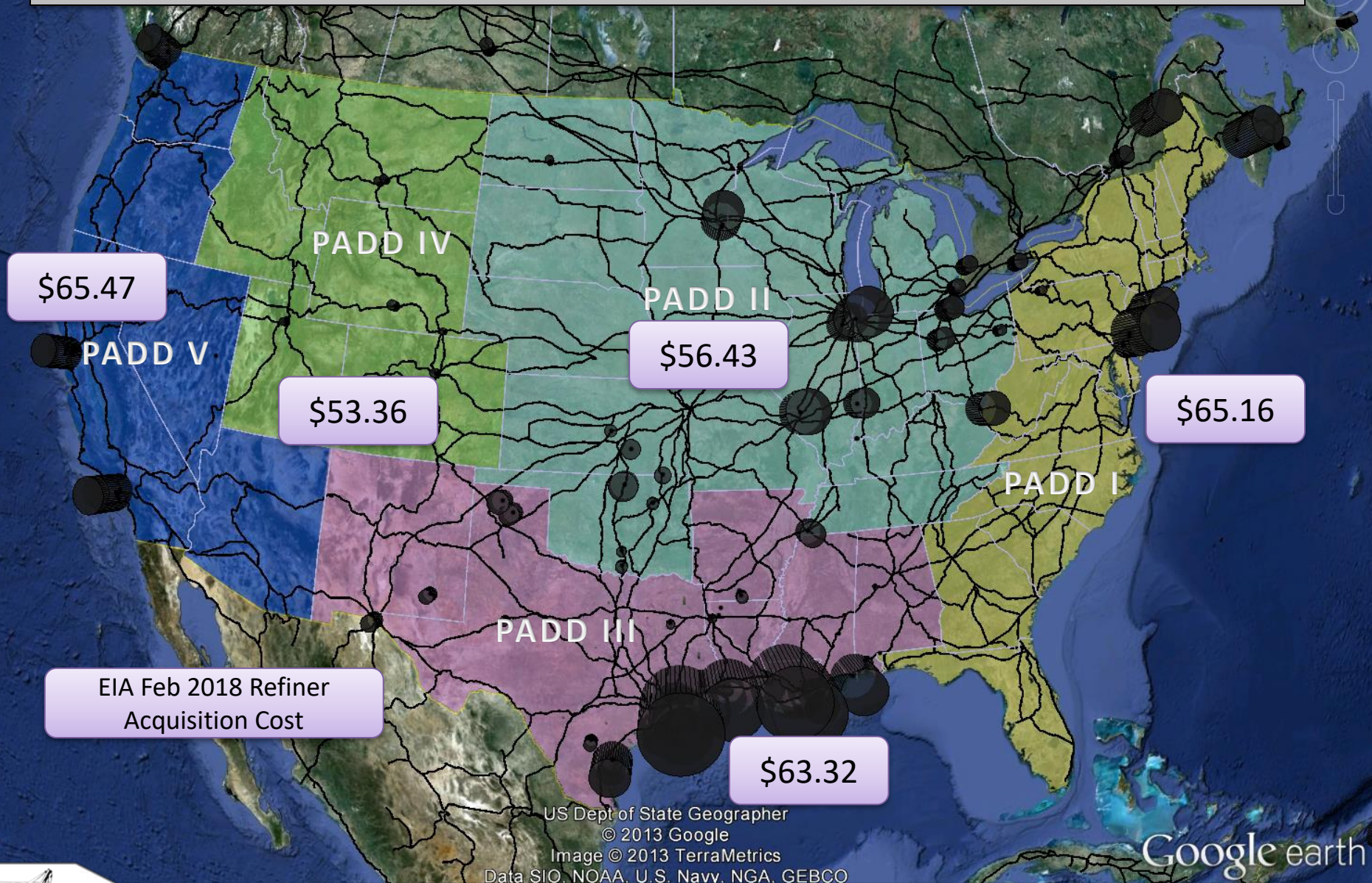
Rail Destinations Market Share (Feb 2018)



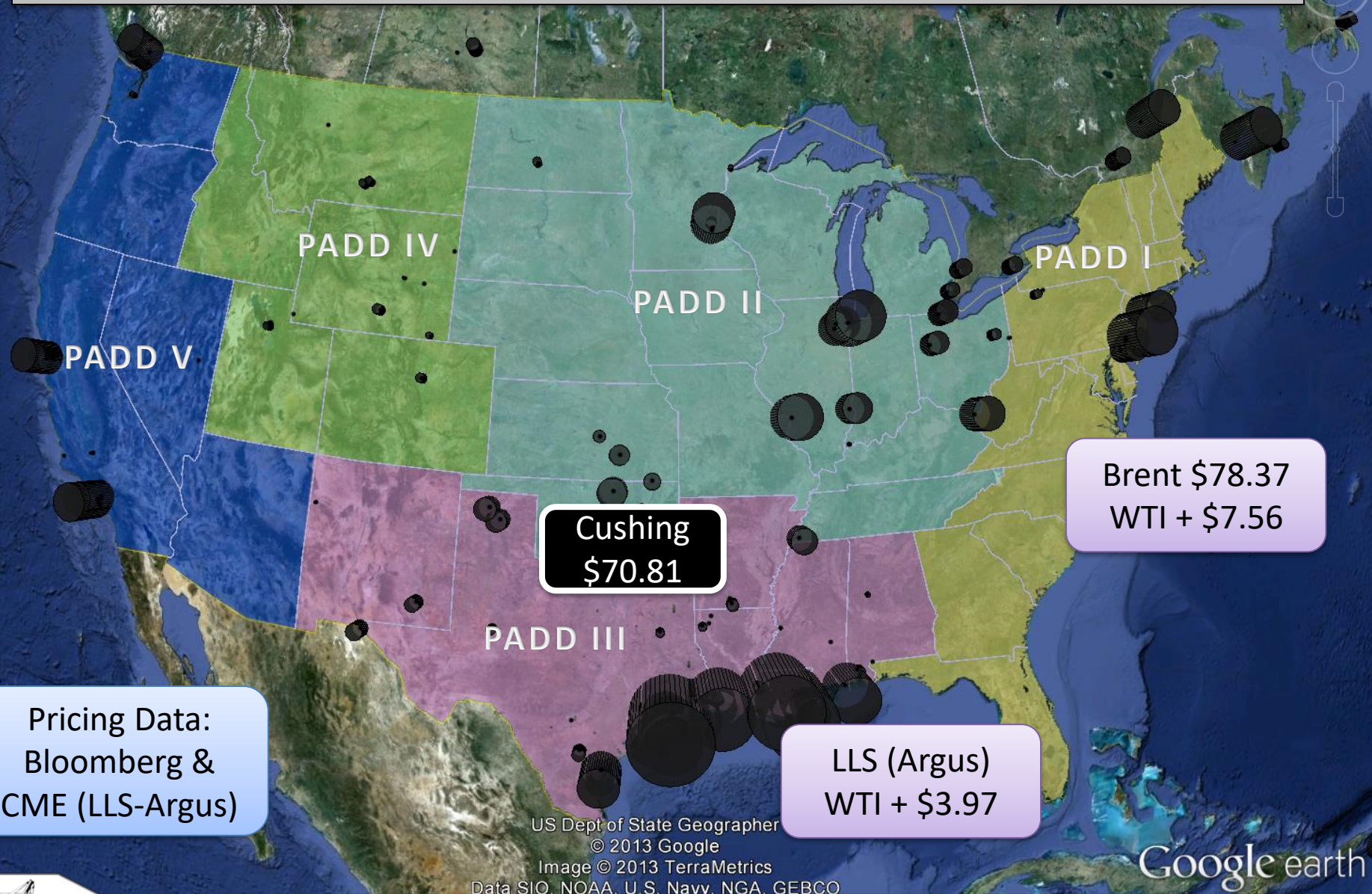

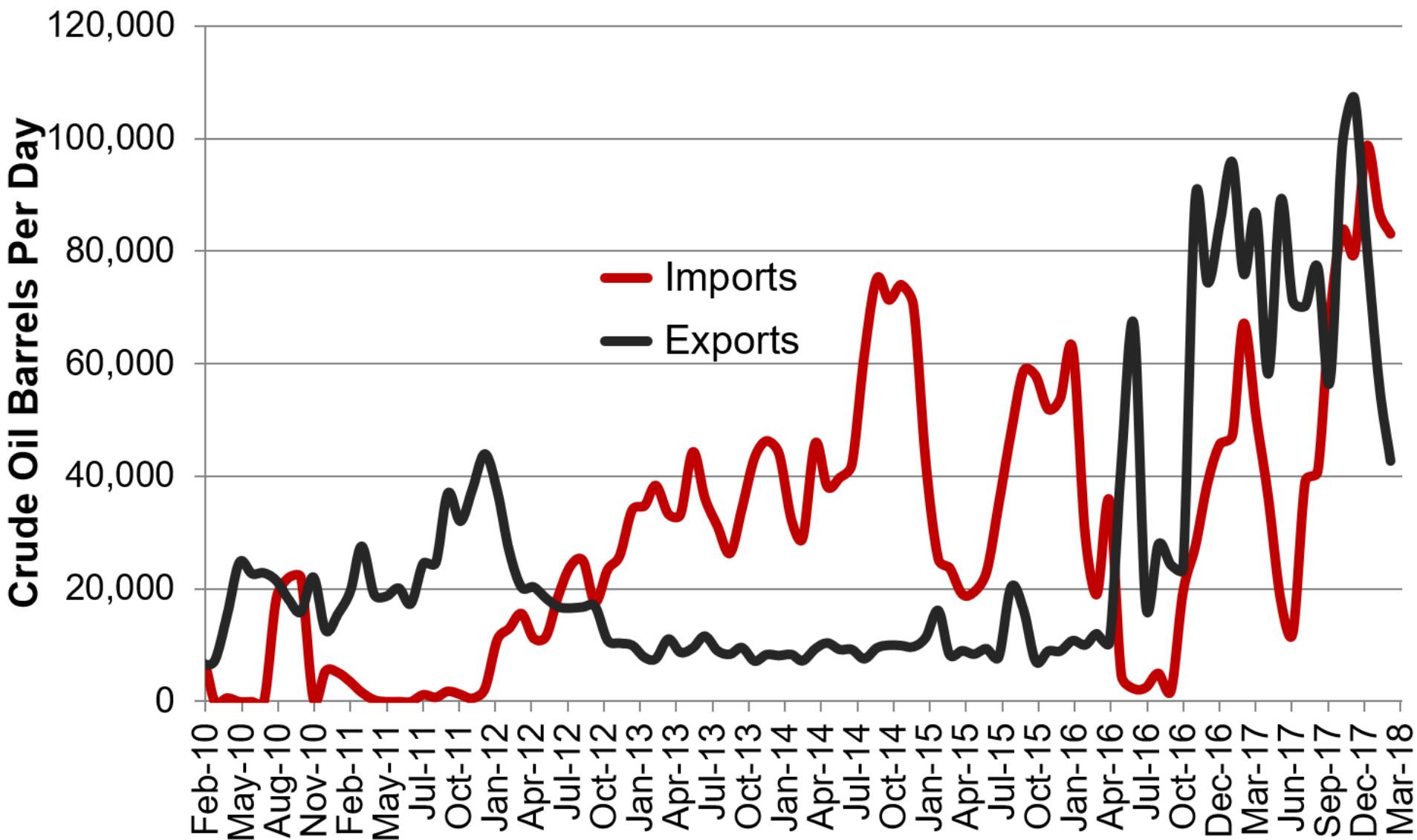
Major Rail Lines and Refineries



Crude Oil Prices – May 15, 2018



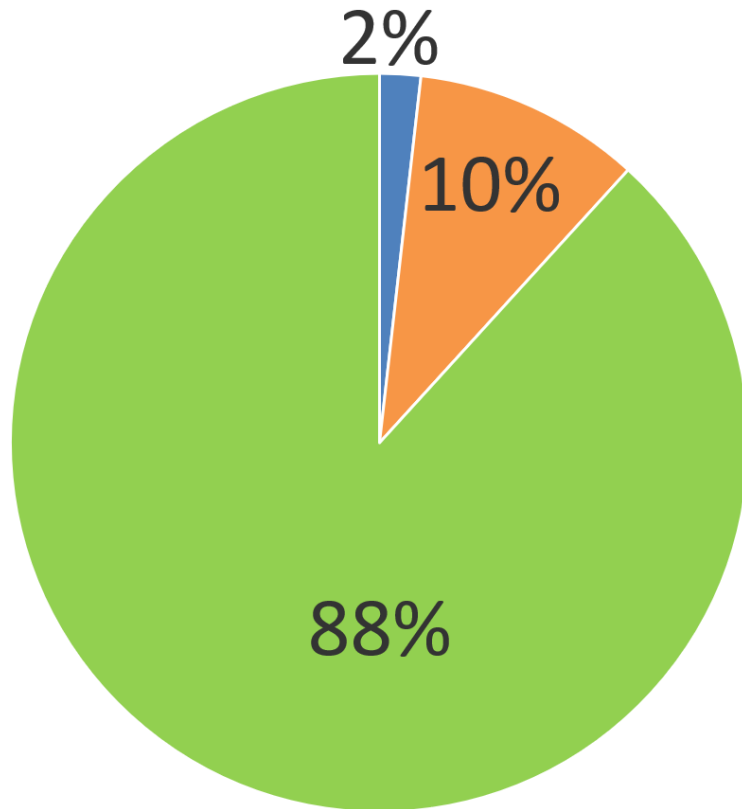
Williston Basin Truck Imports and Exports with Canada

Orange – % flared from wells with at least one mcf sold.

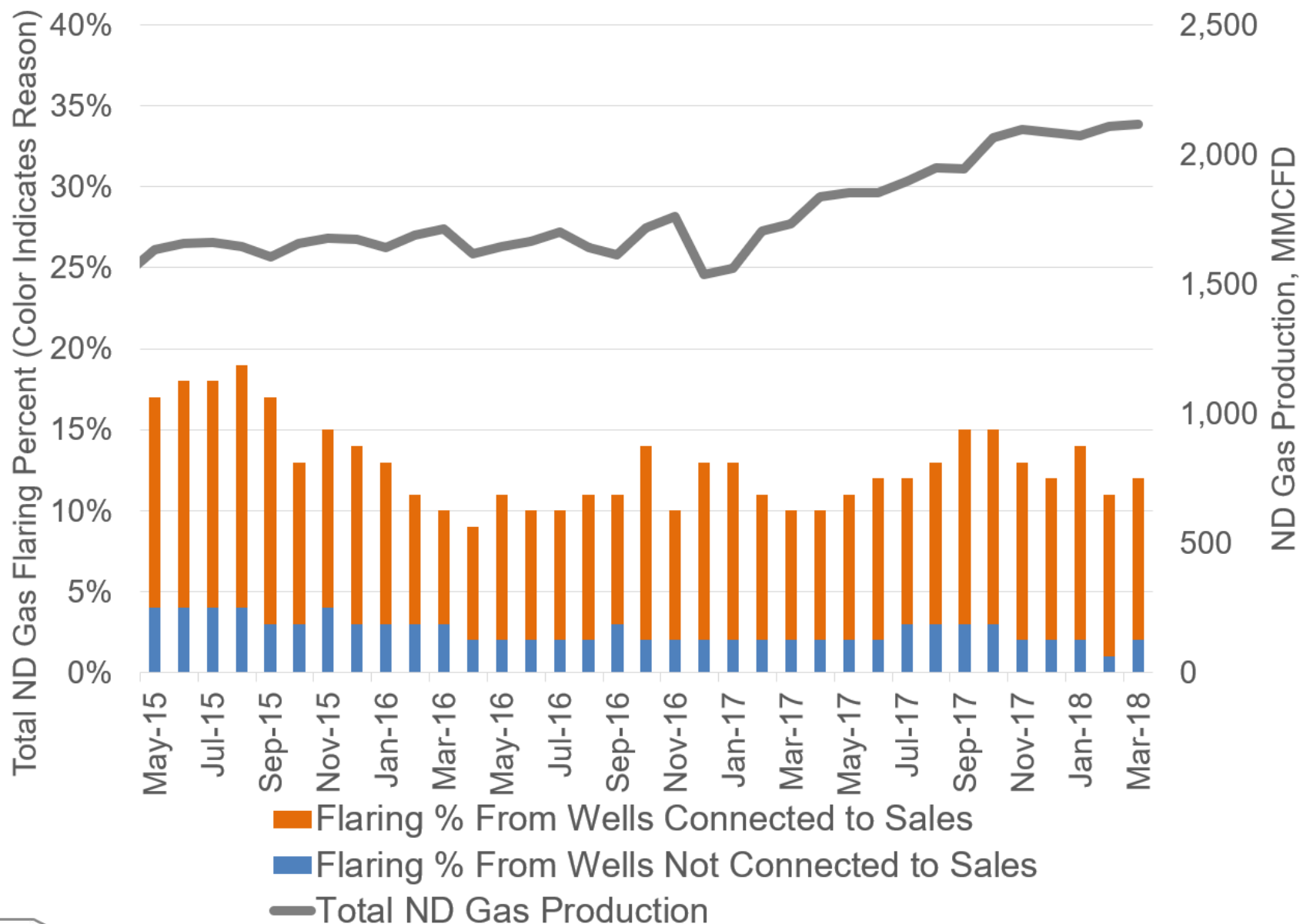
Simple Terms

Orange – Challenges on existing infrastructure

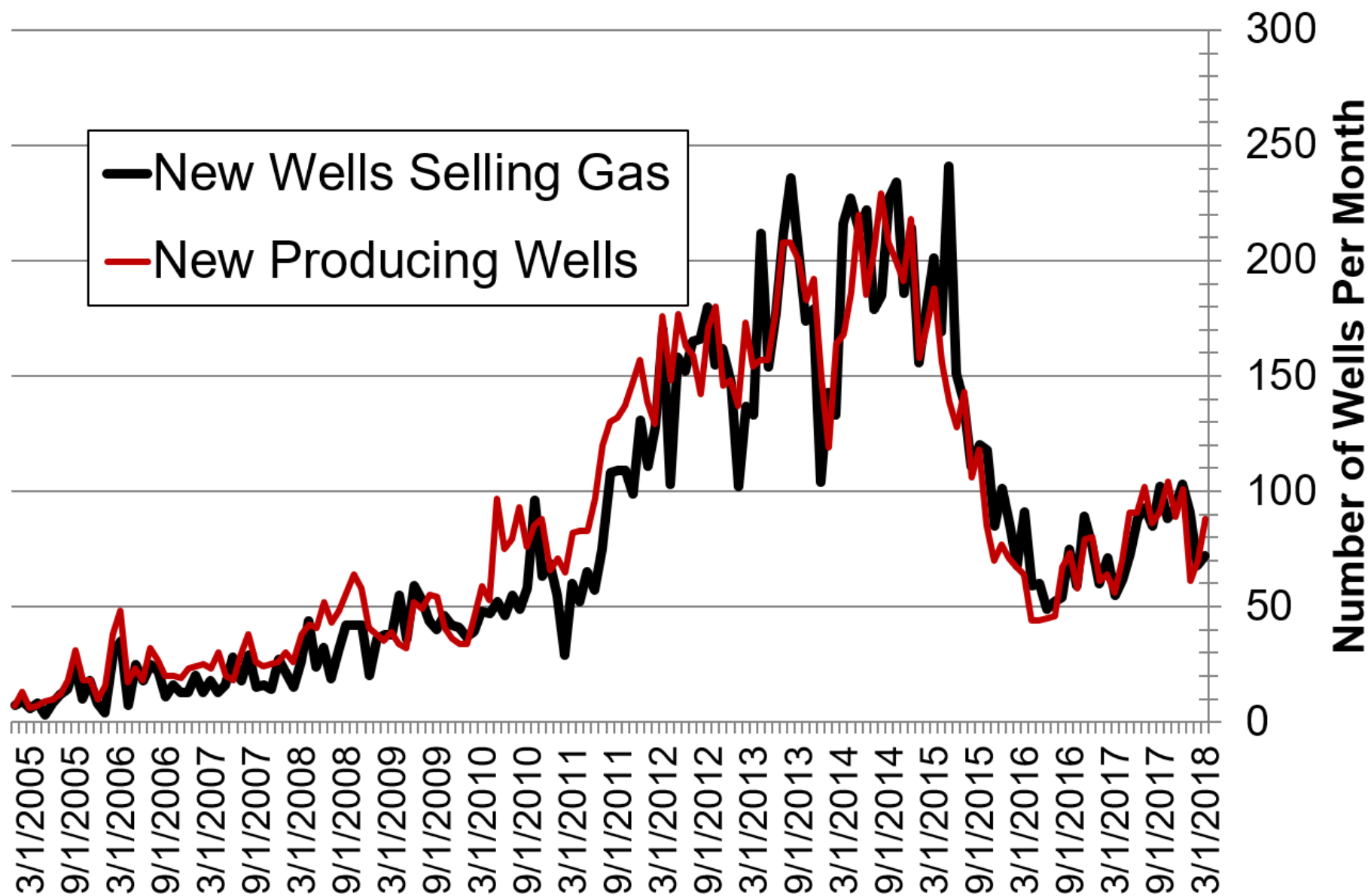
Mar 2018 Data – Non-Confidential Wells



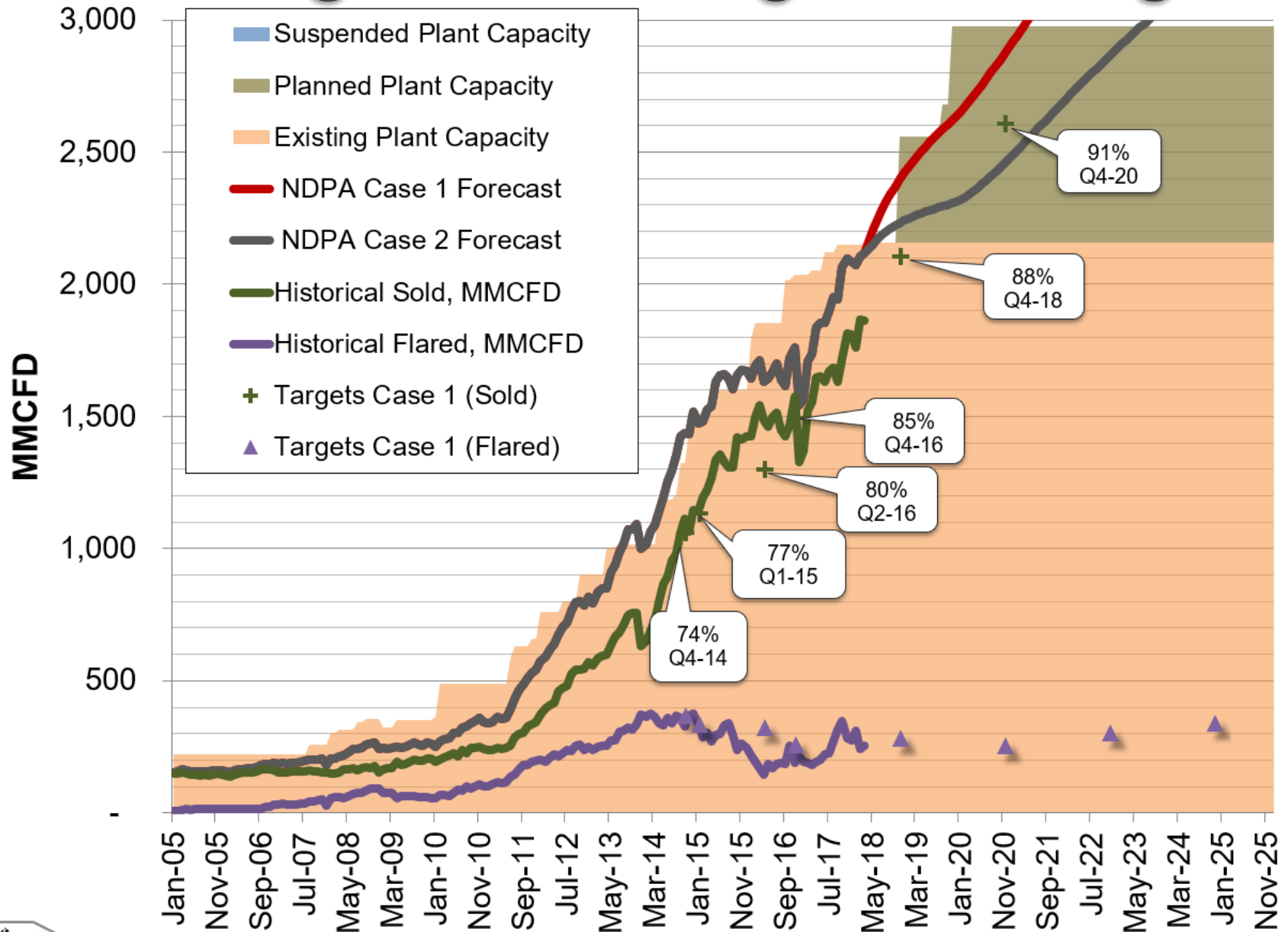

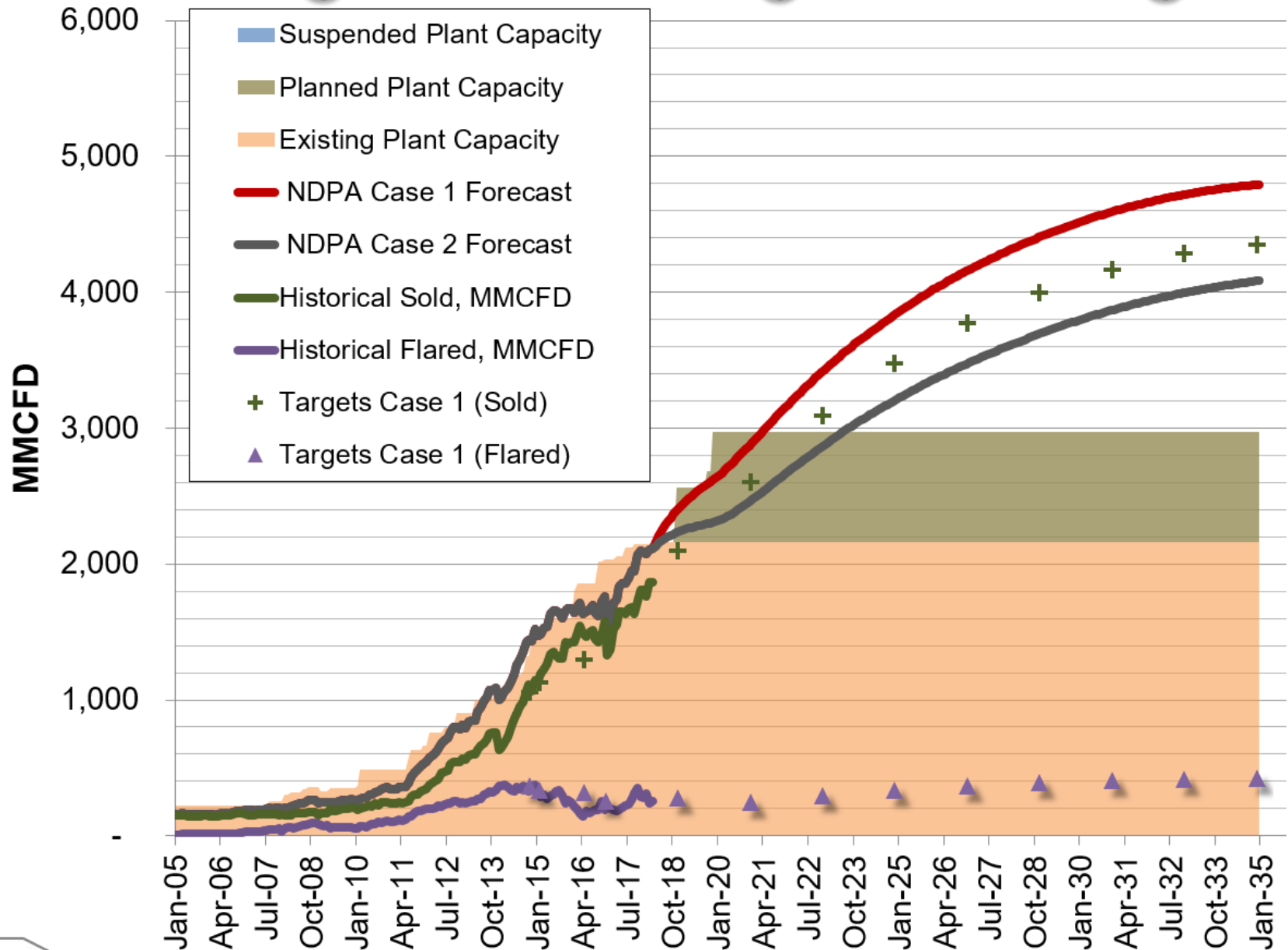
