




Monthly Production Change




Estimated Williston Basin Oil Transportation





Estimated ND Rail Export Volumes




Rail Destinations Market Share (Aug 2019)






Major Rail Lines and Refineries



Crude Oil Prices – Nov. 19, 2019




Williston Basin Truck/Rail Imports and Exports with Canada

Orange – % flared from wells with at least one mcf sold.


Simple Terms

Orange – Challenges on existing infrastructure






