




March to August 75+% M-O-M Oil Drop






Vintage Year of Shut-In Wells – Aug. 2020




GOR Changes in Returning Curtailed Wells

Estimated Williston Basin Oil Transportation







Estimated ND Rail Export Volumes




Rail Destinations Market Share (July 2020)






Major Rail Lines and Refineries



Crude Oil Prices – Oct. 16, 2020




Williston Basin Truck/Rail Imports and Exports with Canada

Orange – % flared from wells with at least one mcf sold.




EIA Oil Price Forecast*





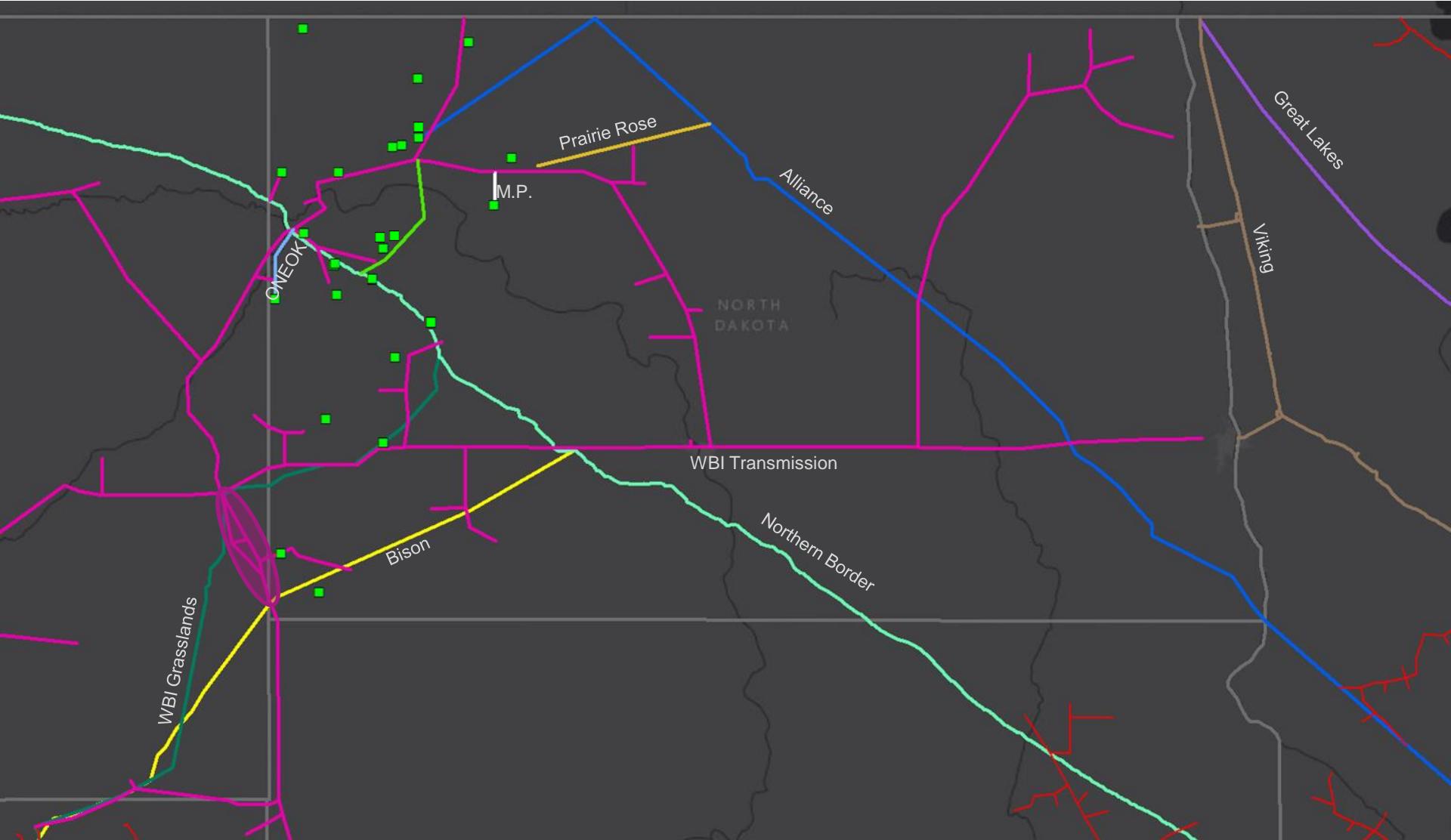
